Participation

The meeting is open to anyone working in Diaconia who is part of a network or an organisation that is a member of Eurodiaconia. Staff/officers of Eurodiaconia member organisations in charge of funding, grants, projects and partnerships will find this meeting interesting and relevant.

Registration

Financial information

Eurodiaconia members from Central and Eastern Europe and from minority churches are eligible to apply for financial support via the registration form (ex-post compensation; read carefully the financial aid guidelines). If you would like to request financial support, we kindly ask you to let us know by registering as soon as possible, but no later than the 4th of September. Our general rule is that a maximum of 2 participants per organisation can attend the network meeting, and due to financial restrictions, only 1 of them can be financially supported if eligible. If you have a particular situation, please contact the Secretariat.

Full sponsorship will only be granted if you attend the entire meeting (full day of the 24th). The Secretariat reserves the right to only reimburse your stay partially, should you not follow the whole programme. In case of conflicting travel schedules and emergencies, please contact the Secretariat.

Venue:

The venue of the meeting will be at: Rue Joseph II 166, 1000 Brussels. We will release a travel note at a later date.

Travel

Participants are asked to book their own travel tickets, following confirmation of their



participation. Those who are requesting financial support are kindly asked to communicate to the Secretariat the cost of the flight tickets. If it exceeds 350 euros, please hold off from the purchase until getting confirmation from the Secretariat.

Accommodation

Eurodiaconia will book and pay for the accommodation of participants who ask for and are granted financial support in a hotel close to the venue. Please do not book your own accommodation if you request financial support.

Other (non-sponsored) participants are asked to book and pay for their own accommodation. If you wish to stay at the same hotel where the sponsored participants are staying, please get in touch with us.
