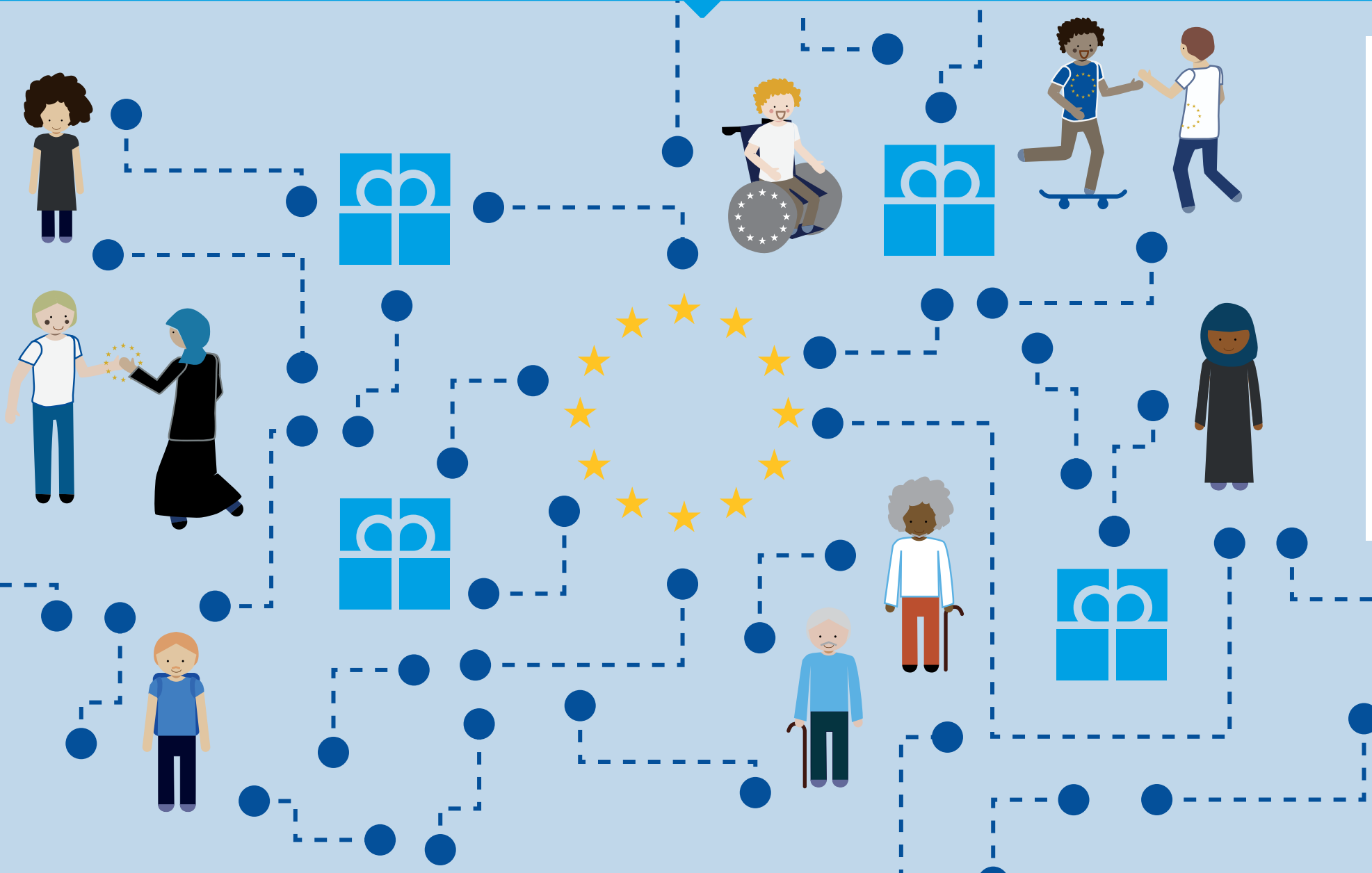

CHAIRPERSON AND SECRETARY GENERAL'S MESSAGE

Giving a voice to the people who have been left forgotten and voiceless should happen at every level of society. From the local examples of our members' work touching the lives of those in need, to discussions of policies that will impact hundreds of millions at the European Union Institutions, God has called us to see people society has forgotten, to acknowledge the beautiful humanity in them and to cry out for those in power to do the same as we demand policies that promote dignity, inclusion, and safety.

2018 has been a year of confronting and speaking truth to power at Eurodiaconia. After the adoption of the European Pillar of Social Rights in 2017, this year was focussed on implementation across the EU, which could revitalise and renew so many sectors around the social economy and its impacts. From access to employment to sustainable farming, we believe the EPSR and a refocused European Semester are vital steps in continuing to ensure that the most vulnerable in our society are not forgotten, and we have continued to push for leaders to adopt a "lowly spirit among the poor" as we look to the future and building a more equitable Europe.

This year Eurodiaconia published a milestone research paper on the EPSR. We were able to follow this work up with many of those in power in the EU institutions, and outcomes have included a breakfast meeting in the European Parliament with MEPs and other stakeholders, policy recommendations, and important trainings both online and in-person for our members.

As we look ahead, there is plenty of work left to be done at every level. We see stark reminders of this all over Brussels as we work in and around the EU institutions; the juxtaposition of the wealthy, harried, powerful employees of

the Parliament and the Commission with the myriad of people in the margins. We must continue to demand recognition and inclusion of those who society can tend to walk past without seeing and to be an empowering voice for them and the organisations who are caring for them every day.

We are extraordinarily grateful that we can participate in the ongoing process of co-creating a more equitable Europe, and that we can serve as a bridge between policy-makers, service providers and the people most in need of those services. It is a privilege to work alongside our members to bring knowledge, funding opportunities, and collective power to people doing the work of bringing justice and fairness to people in need all over Europe today.

There may be plenty of work left to be done, but we are up to the challenge. Together, we can speak alongside those and for those who are not given a voice in our societies. Together, we can continue to pursue equity and justice for those who need it most. Together, we can build a society, a continent, where there is opportunity, integration, dignity, and hope for all.

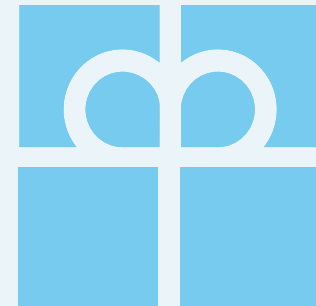
Our vision

FINANCES

Membership fees and member contributions remain essential to co-fund our European Commission grant and to fund activities that are not eligible for European Union support. We are hugely grateful to all our members for the continued financial support which is both generous and sustained.

Our expenditure was closely aligned to our budget with the exception of agreed overspends. However, as the result of some increased costs on some projects we ended the year on a small surplus.
