Under the ESF+ shared management strand, the European Commission doesn't provide direct funding to projects. It's up to the Member States and regions to use the ESF+ funds. They have a lot of freedom in how they do this. With the Commission's approval, a country can choose to have just one national ESF+ programme, set up regional programmes, or do both. ESF+ managing authorities

then pick projects based on what fits with these national or regional plans.
