# THE RURAL-URBAN DIVIDE: AVAILABILITY OF ESSENTIAL SERVICES IN RURAL AND SEGREGATED AREAS

Dear members,

We are pleased to extend an invitation to you for the upcoming 2025 Joint Extreme Destitution and Roma Inclusion Network Meeting, organised in cooperation with our member the Diakonie ECCB. The event will take place in Prague, the Czech Republic, from **June 12th to 13th**, 2025 and will focus on **The Rural-Urban Divide: Availability of Essential Services in Rural and Segregated Areas**.

Our Czech Member Diakonie ECCB is recognised as one of the most important providers of social services in the Czech Republic. Operating in more than 130 locations across the country, Diakonie ECCB has a comprehensive knowledge of the challenges faced by vulnerable groups, both in urban and rural areas. With their work, they aim to offer access to essential and social services for everyone, including families, people experiencing poverty, and Roma communities.

Essential services are vital for promoting social inclusion and ensuring a dignified life for everyone. Principle 20 of the European Pillar of Social Rights states *"Everyone has the right to access essential services of good quality, including water, sanitation, energy, transport, financial services, and digital communications. Support for access to such services shall be available to those in need."*





However, barriers to accessing these services persist: Many rural and remote areas lack adequate infrastructure, such as public transport, financial services, and internet connectivity. Additionally, many individuals face challenges in accessing specific services due to a lack of digital skills. As we work to improve the accessibility and availability of essential services in these areas, it is crucial to also address the challenges faced by Roma communities, who often experience systemic barriers reinforced by spatial segregation and social exclusion. Many Roma individuals living in settlements also live in substandard housing with insufficient connections to water, sanitation, and energy systems.

These are significant challenges because essential services are not only the foundation of basic living standards but also crucial enablers of broader social and economic participation. Improving the availability and accessibility of these services is fundamental to reducing inequalities and ensuring that all people in Europe, regardless of their ethnic background or location, can fully participate in society. Social service providers play a crucial role in supporting those currently left behind by implementing innovative ideas aimed at improving access to essential services in rural areas and settlements.

During our Network Meeting, we will explore **1) the accessibility and availability of essential services in rural areas, with a particular focus on the urban-rural divide. In doing so, 2) we will also integrate the dimension of segregated neighborhoods and settlements, addressing the specific obstacles faced by Roma communities and individuals across Europe.** More information about essential services, Eurodiaconia's members' pivotal activities, and policy recommendations can be found in our latest [policy paper](#).

This meeting will serve as a key platform to strengthen connections between our thematic networks working for and alongside communities in vulnerable situations. It will also foster new partnerships, facilitate mutual learning, and enhance coordination between national and European perspectives. By exchanging insights, best practices, and innovative approaches, participants will contribute to a more inclusive, effective, and sustainable response to these pressing issues.

	<b>Study visit III: SOS Center in Prague</b> <i>The SOS Center provides comprehensive support services, including assistance with employment, housing, financial management, parenting and access to essential services. It also runs leisure activities for young people, such as trips and sport courses.</i>

## Who can participate?

The meeting is open to anyone working in Diaconia who is part of a network or organization that is a member of Eurodiaconia. Those who are likely to find it most interesting are those who work in the provision of essential services in non-urban areas, as well as organisations interested in developing their work in this area. Our general rule is that a maximum of 2 participants per organisation can join the network meeting.

## FINANCIAL INFORMATION

Eurodiaconia members from Central and Eastern Europe and from minority churches are eligible to apply for financial support via the registration form (ex-post compensation; read carefully the [financial aid guidelines](#)). If you would like to request financial support, we kindly ask you to let us know by registering as soon as possible. Our general rule is that a maximum of 2 participants per organisation can join the network meeting, and due to financial restrictions, only 1 of them can be sponsored if eligible (if you have a particular situation, please contact the Secretariat).
